Natalia Bloch is an anthropologist and Associate Professor at the Institute of Anthropology and Ethnology and the Centre for Migration Studies at the Adam Mickiewicz University in Poznań, Poland. She specialises in the anthropology of mobility, conducting research in Tibetan refugee settlements, among migrants and refugees working in the informal tourism sector in India, and on collective accommodation of Ukrainian refugees in Poland. Her books include: *Intersections of Tourism, Migration, and Exile* (co-edited with K. M. Adams, Routledge 2023), *Encounters across Difference. Tourism and Overcoming Subalternity in India* (Lexington Books 2021), and *Urodzeni uchodźcy. Tożsamość pokolenia młodych Tybetańczyków w Indiach* (FNP Monographs 2011). She published in "Critique of Anthropology", "Journal of Refugee Studies", "Critical Asian Studies", "Transfers", and "Annals of Tourism Research".

Natalia Judzińska – PhD in humanities, cultural studies scholar, activist, assistant professor at the Institute of Slavic Studies of the Polish Academy of Sciences. Author of the book *Po lewej stronie sali. Getto ławkowe w międzywojennym Wilnie* published in 2023 by Krytyka Polityczna. Co-initiator of the group *Researchers on the Border*, involved in the documentation and research of the Polish-Belarusian border crisis. Since 2021, she has been providing humanitarian support to people on the move on that border.

Mateusz Krępa – an affiliate researcher of the Centre of Migration Research and a PhD candidate at the Doctoral School of Social Sciences at the University of Warsaw. A member of the *Researchers on the Border* collective. The subject of his doctoral dissertation concerns non-governmental organisations working in the field of migration in Poland. His research interests focus on critical security studies, the concepts of the state of emergency, sovereignty and citizenship. He published in "Central and Eastern European Migration Review" and "Sprawy Narodowościowe – Seria Nowa".

Nasim Ahamed Mondal is a PhD candidate at the Doctoral School of Social Sciences, University of Warsaw. He is a member of the Socio-Economic Research Unit at the Centre of Migration Research. He completed his MPhil as well as MA in Population Studies from the International Institute for Population Sciences, Mumbai, India. His research interests include migration, fertility, and ageing. His current research is focused on the fertility patterns of migrants in the context of low fertility.

Ada Tymińska (Institute of Polish Culture, Interdisciplinary Doctoral School of the University of Warsaw) – cultural expert, lawyer. Her PhD thesis carries out ethnographic and legal research on unaccompanied foreign minors in Poland and their agency in the context of law and procedures.

Her interests include anthropology and ethnographic research on law, in particular migration law, new childhood studies, and art and participatory research. Scholarship holder of the capital city Warsaw for 2023 in the field of literature.

Andrei Yeliseyev is a political scientist, PhD student at the Doctoral School of Social Sciences of the University of Warsaw, and an affiliate researcher of the Centre of Migration Research. He researches the migration diplomacy of Belarus and the migration industry in countries of Central and Eastern Europe.

Lidia Zessin-Jurek is a scholar of Holocaust and Gulag memory and forced migration in Eastern Europe (with a special focus on Polish Jewish refugees). She received her PhD from the European University Institute in Florence, Italy. Most recently, she has worked as an expert for the European Commission's CERV (Citizens, Equality, Rights and Values), the European Holocaust Research Infrastructure (EHRI), and, primarily, as a full-time historian at the Masaryk Institute and Archives of the Czech Academy of Sciences in Prague (2019-2024) as part of the European Research Council's "Unlikely refugee" Project, and at Stockton University in New Jersey in the Holocaust and Genocide Studies program (from 2024).
