The Digital Object Identifier (DOI) is currently the most important one a tool used to confirm the uniqueness of a given scientific text on the Internet, at the same time, it guarantees that the text is assigned a specific address on the Internet, its indelibility and quick access, which significantly facilitates working with texts scientific. Many Western electronic publications (including printed ones) have them electronic version. The DOI number is usually provided in the heading of a given text.

Authors are obliged to cite DOI numbers in their footnotes and from the bibliography.
