Mary Patrice Erdmans is a professor of Sociology at Case Western Reserve University. Her areas of interest include immigration and ethnicity, the intersection of gender, class, and race/ethnicity, and narrative research methods. Her book-length monographs include: *On Becoming A Teen Mom; The Grasinski Girls*; and *Opposite Poles*. She is currently researching return migration among Solidarity refugees.

David A. Gerber is University at Buffalo Distinguished Professor of History Emeritus, and Senior Fellow in the Department of History and in the Center for Disability Studies at the University of Buffalo. Among his works in immigration and ethnic history are *Authors of Their Lives: The Personal Correspondence of British Immigrants to North America in the Nineteenth Century* (2006) and *American Immigration: A Very Short Introduction* (2011). With Bruce J. Dierenfield, he is the author of *Disability Rights and Religious Liberty in Education: The Story behind Zobrest v. Catalina Foothills School District*, which will be published by the University of Illinois Press in 2020.

Walter Kamphoefner is a professor of history at Texas A&M, where he teaches in the field of immigration history. He served as president of the Society for German-American Studies, 2015–17, and held three yearlong guest lectureships at German universities. He has published widely in the field of immigration and ethnicity, with articles in four languages (including Polish) and three books out in both German and English. He has worked intensively with immigrant letters, but also has research interests in bilingual education and the immigrant language transition.

Joanna Kulpińska, PhD – research and teaching assistant at the Institute of American Studies and Polish Diaspora of Jagiellonian University. She graduated from cultural studies with a specialization in the Balkan studies, and ethnic relations & international migrations. At the Institute of American Studies and Polish Diaspora, she prepared a doctoral dissertation devoted to a comparative analysis of migration time trends from a Polish village to the United States

Anna Mazurkiewicz a historian, is an associate professor at the University of Gdansk. She is the author of books and articles on American-Polish relations, American cooperation with political exiles during the Cold War, as well as editor of volumes related to East Central European migrations. Her scholarly interests include transatlantic migrations, U.S. history and the Polish American experience in various aspects.

Neal Pease is professor of History at the University of Wisconsin-Milwaukee, and editor in chief of *The Polish Review*. His research and publication focus is modern Polish and Central European history. He is past president of the Polish American Historical Association, and received that organization's Haiman medal in 2015 for sustained contribution to the study of Polish-American history.

Dorota Praszałowicz is a professor at the Institute for American Studies and Polish Diaspora of the Jagiellonian University in Kraków, Poland. In 2003/2004 she was Fulbright Scholar at the New York University. She focuses in her studies on migration flows from Poland in the past and present. She is the author of the article on Polish migrations: "Poland", in the *Encyclopedia of Migrations and Minorities in Europe from the 17th Century to the Present*, K. Bade, P.C. Emmer, L. Lucassen, J. Oltmer (eds.), Cambridge University Press 2011.

James S. Pula is Professor of History at Purdue University. He is the author and editor of more than a dozen books including *Polish Americans: A Community History* (Macmillan), *Thaddeus Kosciuszko: The Purest Son of Liberty* (Hippocrene), *United We Stand: The Role of Polish Workers in the New York Mills Textile Strikes, 1912 and 1916* (co-author; East European Monographs), *For Liberty and Justice: The Life and Times of Włodzimierz Krzyżanowski* (Ethnic Studies Heritage Center), co-editor of the *Origins of Modern Polish Democracy* (Ohio University Press), and editor-in-chief of *The Polish American Encyclopedia* (McFarland Publications). He was awarded the Oskar Halecki Prize for outstanding books on Polonia three times, as well as being honored with the Mieczysław Haiman Award from the Polish American Historical Association, and the Officer's Cross of the Order of Merit of the Republic of Poland for distinguished contributions to the study of the Polish diaspora.

Adrianna Smell is a doctoral student of Sociology at Case Western Reserve University. Her areas of interest include research methods, social inequality, and public policy.
