Tomasz Krupa is a PhD candidate at Doctoral School 265 *Langues, littératures et so-ciétés du monde*, Inalco (Paris), a member of CREE (EA 4513), and a research assistant in the Institute of Romance Studies at the Jagiellonian University in Kraków (Poland). Working across the fields of reception theory, genetic criticism as well as feminist literary criticism and theory, he is currently investigating the Romanian and French-language literary work of Sorana Gurian and how her texts might be viewed as ones touching upon the concepts of the body and otherness.

Her interests focus on 20th century French literature, esp. Women's writing. Currently, her research, which highly interdisciplinary, concerns such issues as otherness, shaping identity, gender cultural anthropology, and transgression.

Julia Nawrot is PhD at the University of Granada, with the cum laude distinction and international mention (2018), and Extraordinary Doctoral Award (2021). She completed three research stays abroad: at the Jagiellonian University of Kraków (Poland); at the
