- On September 30, professor Marek Zgórniak, retired from work at the Institute.
- On November 1, Jarosław Suchan, PhD started work at the Institute at the post of Assistant Professor at the Department of Modern and Contemporary Art.

Distinctions and awards

- On June 27, professor Andrzej Szczerbski was decorated with the Medal Commemorating 100 Years of Polish Independence by the President of the Republic of Poland.
- On July 2, professor Andrzej Betlej was decorated with the Commander's Cross of the Order of Polonia Restituta by the President of the Republic of Poland, for his contribution to the development of Kraków's cultural life and protection of Poland's cultural heritage.
- On July 4, Dominika Cora, MA, a doctoral candidate at our Institute, was awarded a scholarship from the Minister of Education and Science for outstanding young scientists.
- On July 6, professor Andrzej Betlej was awarded the honorary Order for Merits to Lithuania by the President of Lithuania Gitanas Nausėdė, for his “research, teaching, and museum activities, as well as his invaluable service to the common culture of the Lithuanian and the Polish nations.”
- On July 6, professor Andrzej Szczerbski was awarded the Order for Merits to Lithuania by the President of Lithuania Gitanas Nausėdė.

Events, lectures, publications, and conferences

- On January 26–28, a scientific session took place, jointly organised by the National Museum in Kraków and the Institute of Art of the Jagiellonian University in Kraków, on “Nowy początek. Modernizm w II RP” [“The new beginning. Modernism in the Second Polish Republic”], dedicated to the memory of professor Tomasz Gryglewicz.

- On April 1–2, an international scientific conference took place, jointly organised by the Institut für Europäische Kunstgeschichte Universität Heidelberg and the Institute of Art of the Jagiellonian University in Kraków, on “Genoa, Venice, and their colonies compared, 13th to 16th century. People, power, and art”.
- On April 1, professor Julian Gardner delivered an evening lecture on *The projection of power in two thirteenth-century Italian Maritime Republics*, within the framework of the “Genoa, Venice, and their colonies compared, 13th to 16th century. People, power, and art” conference.
- On April 15–16, another (ninth) edition of the National Scientific Conference “To recognize the past in the present” was held, organized by Jagiellonian University Students’ Scientific Society of Cultural Heritage Preservation. The theme of this year’s conference was: “Krajobraz dziedzictwa” [“The landscape of heritage”].
- On April 26–27, professor Bernard Aikema of Verona University delivered two guest lectures on *The “Dalpontiana Methodus.” A neglected pictorial mode in early modern Europe*, and *Jheronimus Bosch and the Renaissance in Europe*.
- On June 2, students from the Jagiellonian University Students’ Scientific Society of Cultural Heritage Preservation inaugurated the inception of a new student-run research journal “Mundus Hereditatis”.
- On June 14, Paolo Lucca, PhD (of Università Ca’ Foscari in Venice) delivered a guest lecture on *Magic in the Armenian tradition. Polemics and practices*.
- On July 6, The Brill Publishers issued a book by Rafał Quirini-Popławski, PhD, *The art of the Genoese Colonies of the Black Sea Basin (1261–1475)* (Leiden-Boston 2023).
- On September 7–9, a nationwide scientific conference was held, organised by the Bernardine Fathers’ Monastery in Kraków and the Institute of Art of the Jagiellonian University in Kraków, titled “Protocoenobium Ordinis Fratrum Minorum in Polonia. Historia klasztoru i kościoła pod wezwaniem św. Bernardyna ze Sieny w Krakowie, 1453–2023” [“Protocoenobium Ordinis Fratrum Minorum in Polonia. The history of the monastery and church of Saint Bernardino of Siena in Kraków, 1453–2023”].
- On September 28–30, an international scientific conference was held, jointly organised by the Committee of Art History of the Polish Academy of Learning, the Committee of Art Sciences of the Polish Academy of Sciences, and the Institute of Art of the Jagiellonian University in Kraków, titled “Art history and its institutions in the Austro-Hungarian Empire”.
- In October, the Institute hosted a guest seminar by professor Bernard Aikema on “The European Renaissance: Between *Mobilitas* and *Curiositas*”.
- On November 14, a lecture by professor Felicitas Schmieder (Fern Universität in Hagen, Historisches Institut) was hosted, titled *What do you know of the German East? (1940/42). Addressing and creating medieval memory in image and text*.
- On November 25, “Seminarium Zgórniakowianum” was organised – a farewell seminar dedicated to the person of professor Marek Zgórniak. During the event, the following papers, dedicated to the Professor, were presented: Andrzej Betlej, *Naufragio ereptis?*; Dorota Jędruch, *Jeszcze większy Luwr, czyli dalsze losy pewnego tematu [An even larger Louvre, or the continuation of a certain subject]*; Sławomir Skrzyniarz, *Eutychidesowa personifikacja Eurotasu. - On December 8, the Professor Marian Sokołowski Award was presented for the best Master’s thesis in the field of art history, defended at Kraków universities in the academic years 2021/2022 and 2022/2023. The main price was awarded to Kinga Burek-Domżalska for her work “*Zamiana fikcji w fikcję i rzeczywistości w fikcji*”. *Surrealistyczne konteksty sztuki Andrzeja Pawłowskiego w optyce opowiadań Brunona Schulza* [*Turning fiction into fiction, and reality into fiction. Surrealist contexts of Andrzej Pawłowski’s art in the prism of Bruno Schultz’s short stories*], developed under the supervision of professor Wojciech Bałus. Distinctions were granted to Andriy Yegorov for his work *Światło i plastik. Instalacje świetlne Leona Tarasewicza 2017–2020* [*Light and plastics. Leon Tarasewicz’s light installations 2017–2020*], developed under the supervision of professor Wojciech Bałus, and to Klaudia Śnieżek for her work *Romańska architektura opactwa kanoników regularnych w Czerwińsku* [*Romanesque architecture of the abbey of canons regular in Czerwińsk*], developed under the supervision of professor Teresa Rodzińska-Chorąży.
