Between the Jagiellons and the Vasas: Research into Late 16th-Century Polish Parliamentarism

Abstract

The death, without a successor, of Sigismund II August on 7th July 1572 opened the epoch of free royal elections, a new phase in the history of the Polish state, marked by a checkered pattern of individual reigns and intervening interregna. Historians specializing in the late 16th century were usually attracted by these interstices, probably because they produced a number of innovations which paved the way for the establishment of the institution of *electio viritim*, in which all members of the nobility were eligible to vote for the future king. The reign of Stefan Batory (1st May 1576 – 12th December 1586), which filled most of the transition period between the rule of the two major royal houses, the Jagiellons and the Vasas, seems to have had less appeal, even to the historians of law and Polish parliamentarianism. A researcher of the age of Stefan Batory has to confront a number of difficulties which are not faced by those specializing in the periods directly preceding or following that reign. The main obstacle is the dearth of source material that has been printed or is readily available in the Polish archives; moreover, the some of the items that are listed in bibliographies of various studies and monographs of that segment of Polish history are difficult to trace. A thorough sifting of the archives for documentary evidence of the Sejms of 1576–1586 has produced relatively little in all respects, i.e. the circumstances attending their convocation, the preparatory work, the actual proceedings as well their legal and political consequences. The most acute problem for any research in this field is the lack of parliamentary records, or Sejm diaries – of which there are plenty for the preceding and subsequent periods. Alternatively, a searcher of Batory's sejms, can find out what happened in those convocations from thumbnail descriptions in some contemporary chronicles or by digging up the relevant private and public correspondence, examining parliamentary speeches – some of which were printed – or by trying to infer the agenda and points of debate from the text of the acts adopted by the local sejmiks. As the main subject of my research is the legislative activity of the Polish-Lithuanian Sejm in the period 1576–1586 in the context of the legislative competences of the monarch, I extended my archive trawl to those files that could possibly include the text of both parliamentary and royal legislation, like the *Libri Inscriptionum* of the Polish Crown Register *Metrica Regni Poloniae*, volumes 113–133 as well as the inscriptions of the Cracow Land Register, housed at the Wawel Castle Branch of the National Archives. Another important source for the history of Sejms and the effects of their law-making as well as the royal legislation in the age of Stefan Batory are copies of documents that were deposited in various archives or were collected for publication. There is no comprehensive study of the Sejms convened during the reign of Stefan Batory or their legislation, nor is there much information about that chapter of parliamentary history in the historiography of the 16th century especially when compared with researches made for

the preceding and following periods. However, over the last two decades the standstill has been broken by some scholars. Additionally, some information about the Sejms proceedings and lawmaking during the Batory's epoch can be found in the distinct studies touching the miscellaneous aspects of that time including the biographical ones.

Although the fifteen-year period 1572–1587 was crowded with complex developments of wide-ranging significance for Poland's future, historians have tended to view it as a gap between the reign of two great European dynasties, the Jagiellons and the Vasas, and focused their attention on the interregnum that lasted practically for four years after the death of the last Jagiellon king. The same type of bias can be found in the studies of Polish parliamentary history.

The death, without a successor, of Sigismund II August on 7th July 1572 opened the epoch of free royal elections, a new phase in the history of the Polish state, marked by a checkered pattern of individual reigns and intervening interregna. Historians specializing in the late 16th century were usually attracted by these interstices, probably because they produced a number of innovations which paved the way for the establishment of the institution of *electio viritim*, in which all members of the nobility were eligible to vote for the future king. The reign of Stefan Batory (1st May 1576 – 12th December 1586), which filled most of the transition period between the rule of the two major royal houses, seems to have had less appeal, even to the historians of law and Polish parliamentarianism. Yet, Stefan Batory's is the first *regnum* of the new epoch of elective monarchy, which also saw the inauguration in 1569 of the joint Polish-Lithuanian-Prussian Sejm.

The late Professor Stanisław Płaza, one of the most outstanding historians of the early interregna, was well aware of the research deficits in that area.¹ My personal memories of Professor Płaza are closely connected with the figure of Stefan Batory. When I decided to write my MA thesis on a subject that was not related to that king the Professor did not hide his disappointment. Indeed, when I was still a student, on more than one occasion he expressed his surprise that I had not yet decided to write a PhD on that subject. To my reply that I would rather get on with my MA work first, he smiled as if he knew better than me. The encouragement and advice, which I got from him in his office stacked with grey cardboard boxes crammed with his legendary files, came back to me vividly as I was to choose the research topic of my doctoral thesis. It did not take me long to make up mind: it could not be anything but parliamentarianism during the reign of Stefan Batory.

Unfortunately, I was prevented from benefitting from Professor Płaza's invaluable expertise by his death. It happened when my dissertation "Parliamentary and royal legislation during the reign of Stefan Batory (1576–1586)" was still in a very early stage.

I successfully defended it on 28th February 2011; it is about to be published in a series of monographs under the auspices of the Sejm Publishers.

A researcher of the age of Stefan Batory has to confront a number of difficulties which are not faced by those specializing in the periods directly preceding or following that reign. The main obstacle is the dearth of source material that has been printed or is readily available in the Polish archives; moreover, the some of the items that are listed in bibliographies of various studies and monographs of that segment of Polish history are difficult to trace.

A thorough sifting of the archives for documentary evidence of the Sejms of 1576–1586 has produced relatively little in all respects, i.e. the circumstances attending their convocation, the preparatory work, the actual proceedings as well their legal and political consequences. My conclusion is that the relatively little interest in the parliamentarism of the Stefan Batory's reign can be explained by the paucity of sources from that period. It seems that the scarcity cannot be blamed just on the devastations caused by the wars of last century; after all, historians of the late 19th and early 20th century are known to have complained of this problem.² The most acute problem for any research in this field is the lack of parliamentary records, or Sejm diaries – of which there are plenty for the preceding and subsequent periods. The single exception is the Sejm of 1585, the last one of Batory's reign, which produced a few diaries compiled by its participants and observers.³ The remaining sessions either have no diary *sensu stricto* – though we can get some information about them from contemporary chroniclers, and in one case, the Coronation Sejm of 1576, that source allows us to reconstruct the proceedings with sufficient accuracy⁴ – or the extant diaries are barely fragmentary, e.g. the Sejms of 1581 and 1582.⁵ There are also parliaments of the age of Stefan Batory that have left no direct record whatsoever, for example the Sejm of Toruń in 1576 and the Warsaw Sejms of 1578 and of 1579–1580. What we know of them comes primarily from thumbnail descriptions

in some contemporary chronicles.⁶ Alternatively, of course, it is possible to try and find out what happened in those convocations by digging up the relevant private and public correspondence, examining parliamentary speeches – some of which were printed⁷ – or by trying to infer the agenda and points of debate from the text of the acts adopted by the local sejmiks. However, the principal editions of the acts adopted by the sejmiks of Proszowice, Poznań, Kalisz and Sądowa Wisznia between 1576 and 1586 have numerous lacunae, which reflect, as the editors admit, the missing records.⁸ As a result of my

comprehensive searches it has been possible to close some of the gaps and recover some records of other local sejmiks. However, the additional material is not significant enough to alter the general assessment that the parliamentary sources of Stefan Batory's reign remain patchy and irreparably incomplete.

As the main subject of my research is the legislative activity of the Polish-Lithuanian Sejm in the period 1576–1586 in the context of the legislative competences of the monarch, I extended my archive trawl to those files that could possibly include the text of both parliamentary and royal legislation.⁹ I was thinking primarily about the *Libri Inscriptionum* of the Polish Crown Register *Metrica Regni Poloniae*, volumes 113–133.¹⁰ It turned out that no parliamentary legislation of 1576–1586 was entered in the register except that of the Coronation Sejm of 1576. So, with respect to the legislative acts of other Sejms, I assumed that their most reliable record could to be found in the inscriptions of the Cracow Land Register, housed at the Wawel Castle Branch of the National Archives. While short on some key records, the *Metrica Regni Poloniae* contains copies of quite a number of acts known as *uniwersaty* (mainly those issued by the king) and other documents (e.g. remonstrances), which were debated in the Sejms.

To get a sense of the full range of legislative acts adopted by the Sejms or issued by the king as well as other documents that were connected with the parliamentary proceedings I had to examine source materials held in numerous archives in Poland. In the Central Archives of Historical Records in Warsaw I looked through the *Libri Inscriptionum* as well as the relevant materials in the Fond of the Crown Chancery, the *Acta Terrestria et Castrensis Varsaviensis*, the Warsaw Archives of Radziwiłł Family and some minor collections. The National Archives in Cracow, the Wawel Castle Branch, has a number of interesting data apart from the parliamentary acts inscribed in the *Acta Castrensis Palatini Cracoviensis*. More insights into the history of the Sejms and sejmiks can be gleaned from the materials held in the private Archives of the Sanguszko Family and, above all, in the records of the Prussian Estates (*Rezessen der preussischen Ständetage*) in the National Archives in Gdańsk. In the Library of the Czartoryski Family in Cracow most information about the sejms and sejmiks, including copies of various documents and legislative acts, can be found in the so-called Naruszewicz Files. A similar collection of Batoriana, the Stanisław de Broel-Plater Files, is housed in the Ossoliński National Institute in Wrocław. No less valuable, from the point of view of this research project, are the Pawiński Files in the Library of the Polish Academy of Arts and Science in Cracow.

Finally, many individual documents and acts are scattered throughout other MS and old print holdings in the Jagiellonian Library, the National Library and the Kórnik Library.

Another important source for the history of Sejms and the effects of their law-making as well as the royal legislation in the age of Stefan Batory are copies of documents that were collected for publication. In particular, the Pawiński Files contains a lot of material of this kind about the Sejms, the parliamentary sessions, and even the king himself. Many valuable documents of the age found their way into the printed editions of sources, e.g. Adolf Pawiński's contributions to the monumental series *Źródła Dziejowe* [Historical Sources],¹¹ Jan Piotrowski's edition of Batory's diary of the Psków Campaign,¹² Ignacy Janicki's *acta historica* of Batory's reign,¹³ Ignacy Polkowski's collection of Batory's *militaria*,¹⁴ the four volumes of the *Jan Zamoyski Archives*,¹⁵ Teodor Wierzbowski's *Uchańsciana*, featuring Jakub Uchański, Primate of Poland for most of Batory's reign¹⁶ and correspondence of the papal nuncios officiating in Poland during the epoch.¹⁷ As the Polish-Lithuanian Commonwealth was a multi-national state, a fact reflected in the composition of the Sejm, it is also necessary to take into account those printed sources that contain information about the parliamentary work of representatives of the non-

Polish provinces and regions, i.e. the Lithuanians,¹⁸ the Prussians,¹⁹ the inhabitants of the Voivodship of Inflanty (Livonia) and the Duchy of Courland and Semigallia.²⁰

As I have mentioned earlier – most probably due to the paucity of source material in the archives – there is no comprehensive study of the Sejms convened during the reign of Stefan Batory or their legislation, nor is there much information about that chapter of parliamentary history in the historiography of the 16th century especially when compared with researches made for the preceding and following periods. This deficit was noted by number of legal and constitutional historians and restated emphatically in a state-of-research survey published in 1995: "All of Stefan Batory's Sejms have been waiting in vain for an authoritative, full-length article, let alone a monographic study".²¹ However, over the last two decades the standstill has been broken by Ewa Dubas-Urwanowicz. In a series of books and articles she analyzed the parliamentary practices of that period, focusing on the growing rift between the king and the gentry. In her view that tension was a harbinger of a constitutional crisis which was to come to a head during the reign of the Vasa kings.²² However, without a careful examination of the circumstances at-

tending the summoning of each of the general Sejms, the reasons why it was convened and its proposed agenda, it is hardly possible to offer a convincing account of its work, procedures and the situation in which a given piece of legislation was passed (very often both the decisive vote as well as the shape of the law depended on shifts in the balance of power in the house). There are only few studies that address the problems of parliamentary procedure and the legislative process in the age of Stefan Batory. The pioneering work in this field was done in a series of articles and books, most of them by Wincenty Zakrzewski, commemorating tercentennial of Batory's death.²³ In the early 20th century Zakrzewski was joined by Kazimierz Lepszy.²⁴ More short articles on the parliamentary practices under Batory were written in the 1930s by Józef Siemieński,²⁵ and in the

1980s by Witold Rodkiewicz²⁶ and, with the focus on Royal (Polish) Prussia, by Andrzej Klonder.²⁷ More recently a number of more broadly-based studies were published by Leszek Kieniewicz,²⁸ Ewa Dubas-Urwanowicz and Dariusz Makiłła.²⁹ The new century was marked by the Warsaw historians with the inauguration of a series of monographs on Polish-Lithuanian relationships and the birth of Lithuanian parliamentarism.³⁰ A comprehensive study of the functioning and the competences of the Sejm during the reign of Stefan Batory (in the series ‘History of the Polish Sejm’) came from the pen of Anna Sucheni-Grabowska.³¹ This list would not be complete without several biographies of the king himself (most notably “Stefan Batory” by Jerzy Besala) and some remarkable figures from his entourage.³² Well-researched studies of Poland’s foreign relations in the age of Batory were published by Kazimierz Dopierała,³³ Ludwik Boratyński,³⁴ Janusz

Pajewski,³⁵ and Aleksander Kraushar.³⁶ Stefan Batory's religion and the position of the Catholic Church during his reign were discussed in two articles published in the 1920s by Michał Morawski³⁷ while more recently the relations between various religious denominations at that time were examined by Jan Dzięgielewski.³⁸

My research into the legislation produced during reign of Stefan Batory provided the basis not only for my doctoral dissertation on the parliamentary and royal legislation of that period but also on more than a dozen articles.³⁹ Together they present a picture of

parliamentarism in the Polish-Lithuanian Commonwealth in the years 1576–1586. In my account I tried to describe the facts and processes with maximum objectivity and studiously avoid the temptation, familiar to all historians, to judge and to moralize or to speculate about the causes, the effects, or the possible scenarios. My study is intended to show that the parliamentary procedures and the dual legislative process (parliamentary and royal) in the epoch of Stefan Batory had a distinct profile, different from those of the adjacent epochs of the Jagiellons and the Vasas. I hope that my contribution, in a way prompted by the encouragement of the late Professor Stanisław Plaza, has brought some light into a relatively unexplored tract in the history of Polish parliamentarism.

Między Jagiellonami i Wazami: badania nad dziejami parlamentaryzmu staropolskiego schyłku XVI w.

Streszczenie

Moment dziejowy obejmujący 15 lat, które rozdzielają panowanie dwóch wielkich europejskich monarchów dynastii: Jagiellonów i Wazów, stanowił początek nowej ery w historii polskiej państwowości zwanej epoką królów elecyjnych. Badacze polskich dziejów schyłku XVI w., jeśli zajmowali się tym okresem, z reguły koncentrowali się na periodach bezkrólewi, mniejzym zainteresowaniem obdarzając czas panowania Stefana Batorego, swoim trwaniem (od 1 maja 1576 r. do 12 grudnia 1586 r.) obejmującego większość wspomnianego piętnastolecia. Badacz epoki Stefana Batorego spotyka się z wieloma trudnościami, które zasadniczo obce są uczonym zajmującym się okresami zarówno bezpośrednio poprzedzającymi, jak i następującymi po niej. Dotyczą one materiałów źródłowych znajdujących się w polskich archiwach oraz wydrukowanych, a także pozycji literatury naukowej o monograficznym czy też syntetycznym charakterze. Kwerenda źródeł, które przechowywane są w polskich archiwach, ukazała ubogość danych dotyczących sejmów obradujących w latach 1576–1586, szczególnie problematyczna okazała się znikoma liczba diariuszy sejmowych, w które obfitują okresy panowania Jagiellonów i Wazów, a które dla historyka parlamentarysty stanowią podstawę badań. Uczony próbujący pozać obrady sejmów epoki batoriańskiej zdany jest na bardzo ogólnikowe opisy zdarzeń w kronikach oraz na rekonstruowanie ich przebiegu z korespondencji prywatnych i urzędowych, przemów poselskich czy też uchwał sejmikowych. Biorąc pod uwagę przedmiot badań, a więc omówienie prawodawczych funkcji polsko-litewskiego sejmu w latach 1576–1586 w konfrontacji z legislacyjnymi kompetencjami monarchy, kwerendą źródłową objęte zostały przede wszystkim te jednostki archiwalne, w których prawdopodobne było znalezienie tekstów aktów prawodawczych zarówno sejmowych, jak i królewskich, w tym Metryka Koronna, Księgi Wpisów, Księgi Ziemskie Krakowskie znajdujące się w Archiwum Narodowym w Krakowie, Oddziale na Wawelu. Cennym źródłem wiedzy w zakresie obrad sejmowych i skutków jego działalności legislacyjnej, jak i aktów prawnych wydanych przez króla w czasie panowania Stefana Batorego, są wydrukowane lub też zdeponowane w archiwach kopiarium różnych dokumentów. Sejmy obradujące za panowania Stefana Batorego, w tym ich działalność prawodawcza (w przeciwieństwie do okresów wcześniejszego Jagiellonów i późniejszego Wazów), nie mają żadnego opracowania monograficznego, a informacje na ich temat zawarte w repetytoriach syntetycznych zajmują proporcjonalnie mało miejsca. Dopiero niedawno nieliczni badacze podjęli tematykę rządów księcia siedmiogrodzkiego na polsko-litewskim tronie, również w kontekście jego relacji

z innymi stanami sejmującymi. Niektóre dane na temat praktyki sejmowania i tworzenia prawa w tym czasie znaleźć można także w innych opracowaniach dotyczących różnych aspektów epoki batoriańskiej, również w tych o charakterze biograficznym.
